Dear Alumni Members,

10. Enrich the emotional bonding among the students, alumni and teachers.
11. Complete Plan to announce and conduct of General Body Meeting.
12. To consider and adopt the audited Balance Sheets and Income and Expenditure Accounts of the Society up to the financial year ended by 31.03.2021
13. The nominated Office bearer and committee member shall discharge his / her duties to meet the objectives of the Association with utmost care and transparency. If any act of the office bearer / s is proved to be against the interest of the Association and or not acted in good faith, can be by my order, may be recalled from the office from any post of the Executive Committee.
